Sessions will be listed as approved for either the technical or administrative categories.

Obtaining Credit for Approved Sessions

Attendees must follow the League's attendance procedures to obtain your session attendance certificate. These procedures are available on the League's conference website.

Certificates

After the conference, attendees must log onto the League website to obtain certificates for sessions they attended. League certificates are available from November 27, 2023 – May 1, 2024.

Certificate Renewal

Individuals holding Board Secretary, Zoning Official, and/or Land Use Administrator certificate(s) must submit a copy of their certificate of completion for any of the League sessions they attended. Simply obtain your certificates from the League's website immediately after the event and retain them with your continuing education records. When your Rutgers PZ certificate is due for renewal, submit copies of your League certificate(s) with your renewal application packet. Do not submit copies of these certificates to CGS immediately after the League concludes. They will only be accepted with your renewal application. Please be sure to print your certificates from the League's website in accordance with the deadline requirements listed on their website.

New Jersey Planning Officials (NJPO)
